







5	That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6	That the principal and manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time . The school undertake to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land .
7	That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school .
